ORDINARY BUSINESS

ORDINARY RESOLUTIONS

1. To receive the report of the Directors and the audited financial statements of the Company for the year ended 30 June 2015.
2. To re-elect as a Director of the Company Mr Nicholas Smith, who retires by rotation under the Articles of Association of the Company and, being eligible, offers himself for re-election.
3. To re-appoint as a Director of the Company Mr Hari Kiran Vadlamani, appointed during the year and retiring as a director in accordance with the Articles of Association of the Company at the conclusion of the meeting and, being eligible, offering himself for re-election as a director of the Company.
4. To re-appoint BDO LLP as auditors of the Company to act until the conclusion of the next Annual General Meeting and to authorise the Directors to determine the remuneration of the auditors.

SPECIAL BUSINESS

ORDINARY RESOLUTION

5. That to the exclusion of and in substitution for any such authority previously conferred upon them and subsisting at the date of this Resolution (save to the extent that the same may already have been exercised and save for any such authority granted by statute), the Directors be and are hereby authorised, generally and unconditionally for the purpose of section 551 of the Companies Act 2006 to allot equity securities (as defined in Section 560 of that Act) up to a maximum aggregate nominal amount of £205,000 provided that:
 - (a) this authority shall expire on the date of the next annual general meeting of the Company; and
 - (b) the Company may before such expiry date make an offer, agreement or other arrangement which would or might require equity securities to be allotted after such expiry and the Directors may allot equity securities pursuant to any such offer, agreement or arrangement as if the authority hereby conferred had not so expired.

SPECIAL RESOLUTION

6. That in substitution for all existing and unexercised authorities and subject to the passing of the immediately preceding Resolution, the directors of the Company be and they are hereby empowered pursuant to section 570 of the Act to allot equity securities (as defined in section 560 of the Act) pursuant to the authority conferred upon them by the preceding Resolution as if section 561(1) of the Act did not apply to any such allotment provided that the power conferred by the Resolution, unless previously revoked or varied by special resolution of the Company in general meeting, shall be limited:
- (a) to the allotment of equity securities in connection with a rights issue in favour of ordinary shareholders where the equity securities respectively attributable to the interest of all such shareholders are proportionate (as nearly as may be) to the respective numbers of the ordinary shares held by them subject only to such exclusions or other arrangements as the directors of the Company may consider appropriate to deal with fractional entitlements or legal and practical difficulties under the laws of, or the requirements of any recognised regulatory body in, any territory; and
 - (b) to the allotment (otherwise than pursuant to sub-paragraphs (a) above) of equity securities up to an aggregate nominal amount of £205,000 in respect of any other issues for cash consideration,

and shall expire on the date of the next Annual General Meeting of the Company save that the Company may before such expiry make an offer or agreement which would or might require equity securities to be allotted after such expiry and the directors may allot equity securities in pursuance of such offer or agreement as if the power conferred hereby had not expired.

OTHER BUSINESS

7. To consider, in accordance with Section 656 of the Act, whether any, and if so what, steps should be taken to deal with the net assets of the Company forming less than half of its called-up share capital.

The Directors consider that this situation be dealt with by continuing with their previously announced strategy to actively pursue the Company's claim - currently quantified at US\$1.315 billion plus interest from July 2014 - against the Republic of Indonesia for unlawful measures taken by Indonesia against Churchill's interests in the East Kutai Coal Project.

EXPLANATORY STATEMENT

This Explanatory Statement has been prepared for the information of the Shareholders in connection with the business to be conducted at the Annual General Meeting to be held at 10.00am on 23 December 2015.

The purpose of this Explanatory Statement is to provide information which the Directors believe to be material to Shareholders in deciding whether or not to pass the Resolutions in the Notice of Meeting.

Entitlement to attend and vote

Pursuant to Regulation 41 of the Uncertificated Securities Regulations 2001, the Company specifies that only those members registered on the Company's register of members 48 hours (excluding non-working days or parts of days) before the time of the Meeting shall be entitled to attend and vote at the Meeting.

Appointment of proxies

If you are a member of the Company at the time set out above, you are entitled to appoint a proxy to exercise all or any of your rights to attend, speak and vote at the Meeting and you should have received a proxy form with this notice of meeting. You can only appoint a proxy using the procedures set out in these notes and the notes to the proxy form.

A proxy does not need to be a member of the Company but must attend the Meeting to represent you. Details of how to appoint the Chairman of the Meeting or another person as your proxy using the proxy form are set out in the notes to the proxy form. If you wish your proxy to speak on your behalf at the Meeting you will need to appoint your own choice of proxy (not the Chairman) and give your instructions directly to them.

You may appoint more than one proxy provided each proxy is appointed to exercise rights attached to different shares. You may not appoint more than one proxy to exercise rights attached to any one share. To appoint more than one proxy, please contact the registrars of the Company, Share Registrars Limited on +44 (0)1252 821 390.

A vote withheld is not a vote in law, which means that the vote will not be counted in the calculation of votes for or against the resolution. If no voting indication is given, your proxy will vote or abstain from voting at his or her discretion. Your proxy will vote (or abstain from voting) as he or she thinks fit in relation to any other matter which is put before the Meeting.

Appointment of proxy using hard copy proxy form

The notes to the proxy form explain how to direct your proxy how to vote on each resolution or withhold their vote.

To appoint a proxy using the proxy form, the form must be completed and signed; sent or delivered to Share Registrars Limited at Suite E, First Floor, 9 Lion & Lamb Yard, Farnham, Surrey GU9 7LL or by facsimile transmission to +44 (0)1252 719 232; and received by Share Registrars Limited no later than 48 hours (excluding non business days or parts of days) prior to the Meeting.

Any power of attorney or any other authority under which the proxy form is signed (or a duly certified copy of such power or authority) must be included with the proxy form.

Appointment of proxy by joint members

In the case of joint holders, where more than one of the joint holders purports to appoint a proxy, only the appointment submitted by the most senior holder will be accepted. Seniority is determined by the order in which the names of the joint holders appear in the Company's register of members in respect of the joint holding (the first-named being the most senior).

Changing proxy instructions

To change your proxy instructions simply submit a new proxy appointment using the methods set out above. Note that the cut-off time for receipt of proxy appointments (see above) also apply in relation to amended instructions; any amended proxy appointment received after the relevant cut-off time will be disregarded.

If you submit more than one valid proxy appointment, the appointment received last before the latest time for the receipt of proxies will take precedence.

Termination of proxy appointments

In order to revoke a proxy instruction you will need to inform the Company using one of the following methods:

In either case, the revocation notice must be received by Share Registrars Limited no later than 48 hours (excluding non business days or parts of days) prior to the Meeting.

If you attempt to revoke your proxy appointment but the revocation is received after the time specified then, subject to the paragraph directly below, your proxy appointment will remain valid.

Appointment of a proxy does not preclude you from attending the Meeting and voting in person. If you have appointed a proxy and attend the Meeting in person, your proxy appointment will automatically be terminated.

Issued shares and total voting rights

As at 13th November 2015, the Company's issued share capital comprised 136,942,277 ordinary shares of £0.01 each. Each ordinary share carries the right to one vote at a general meeting of the Company and, therefore, the total number of voting rights in the Company as at 13th November 2015 is 136,942,277.

You may not use any electronic address provided either in this notice of general meeting; or any related documents (including the chairman's letter and proxy form), to communicate with the Company for any purposes other than those expressly stated.

CREST

CREST members who wish to appoint a proxy or proxies through the CREST electronic proxy appointment service may do so for the General Meeting and any adjournment(s) thereof by using the procedures described in the CREST Manual.

CREST Personal Members or other CREST sponsored members, and those CREST members who have appointed a voting service provider(s) should refer to their CREST sponsor or voting service provider(s), who will be able to take the appropriate action on their behalf.

In order for a proxy appointment or instruction made using the CREST service to be valid, the appropriate CREST message (a "CREST Proxy Instruction") must be properly authenticated in accordance with Euroclear UK & Ireland Limited's specifications and must contain the information required for such instructions, as described in the CREST Manual (available via euroclear.com/CREST).

BUSINESS OF THE MEETING

RESOLUTION 1 – FINANCIAL STATEMENTS AND REPORTS

In accordance with the Articles of Association, the business of the Annual General Meeting will include receipt and consideration of the annual financial report of the Company for the financial year ended 30 June 2015 together with the declaration of the directors, the directors' report, and the auditor's report.

Shareholders may view the Company annual financial report on its website at www.churchillmining.com.

RESOLUTION 2 – RE-ELECTION OF DIRECTOR – MR NICHOLAS SMITH

The Articles of Association require that in the annual general meeting in every year one-third of the Directors for the time being, or, if their number is more than three but not a multiple of three, then the number nearest to but not exceeding one-third, must retire from office.

Mr Nicholas Smith retires by rotation and, being eligible, seeks re-election.

The Board (excluding Mr Smith) recommends that shareholders vote in favour of the re-election of Mr Smith as a Director.

RESOLUTION 3 – RE-APPOINTMENT OF DIRECTOR – MR HARI KIRAN VADLAMANI

The Articles of Association require that when the Directors have appointed a person to the Board, any person so appointed will retire from office at the next annual general meeting and will then be eligible for re-appointment at that meeting.

Mr Vadlamani accordingly retires and, being eligible, seeks re-appointment.

The Board (excluding Mr Vadlamani) recommends that shareholders vote in favour of the re-election of Mr Vadlamani as a Director.

RESOLUTION 4 – TO RE-APPOINT BDO LLP AS AUDITORS OF THE COMPANY AND TO AUTHORISE THE DIRECTORS TO DETERMINE THE REMUNERATION OF THE AUDITORS

BDO LLP has acted as the auditors for the Company for the last six financial years.

The Directors recommend that BDO LLP be re-appointed as auditors of the Company.

RESOLUTION 5 – TO AUTHORISE THE DIRECTORS TO ALLOT RELEVANT SECURITIES UP TO A MAXIMUM AGGREGATE NOMINAL AMOUNT OF £205,000

The Directors propose that authority to allot equity securities up to a maximum nominal amount of £205,000 be approved.

This is an enabling resolution, other than detailed below the Directors currently have no plans to allot any of the 20,500,000 ordinary shares that will be available for issue but they consider it desirable that the specified amount of authorised but unissued share capital available for issue.

RESOLUTION 6 – TO DIS-APPLY PRE-EMPTION RIGHTS UP TO A MAXIMUM NOMINAL AMOUNT OF £205,000

If the Directors wish to allot any equity securities of the Company for cash otherwise than pro-rata to existing shareholdings in accordance with the authority proposed in Resolution 5, the Directors require approval to allot equity securities for cash other than in accordance with the statutory pre-emption rights.

In line with common practice, Resolution 6 therefore seeks approval for the dis-application of pre-emption rights over approximately 15% of the current issued share capital. This is also an enabling resolution and provides capacity and flexibility for the Directors for 20,500,000 equity securities that will be available otherwise than pre-emptively for cash consideration (nominal amount £205,000) including any shares to be issued to Directors in lieu of fees and the grant of any options or warrants during the period.

In line with past years and in recognition of the Company's need to continue to preserve its cash position and to align the directors interests with shareholders, the Chairman and Non-Executive Directors have agreed to take their standard and any pro-rata Directors' fees for the 2015 year by subscribing for Churchill shares rather than receiving cash. The current annual Directors' fees payable total US\$221,000. In addition the Company Secretary has agreed to take A\$24,000pa in fully paid shares in lieu of cash remuneration. Subject to approval of this resolution the shares will be issued based on a price calculated as the volume weighted average mid-market price of the Company's Ordinary Shares as listed on the AIM market of the London Stock Exchange plc for the period 1 January 2015 to 31 December 2015.
